Health Insurance is a requirement for F-1 student. All students will be enrolled in the Student Insurance Plan administered by Student Blue, Blue Cross Blue Shield of North Carolina. Some students may qualify for a waiver of the plan: <https://healthypack.dasa.ncsu.edu/>. If you need to purchase the Student Insurance Plan from Student Blue, Blue Cross Blue Shield of North Carolina, please allow for a minimum of \$2,540.00 (subject to increase) per year.

A student who plans to remain in the US during the summer will need approximately \$5,010 for living expenses. Students should not expect employment, either part-time or full-time during the summers, to be a significant means of support.

Applicants who will be financially sponsored by his/her employer, home government or university: Must provide an Official Letter of support from his/her scholarship or fellowship source with the current date and a signature indicating the amount and duration of the award (4-5 for a Bachelor's degree). The letter should also include the applicant's name, academic program, and that it is valid specifically for attendance at North Carolina State University.
